Horse Haven of Tennessee of Lenoir City, is Now Accredited by the Global Federation of Animal Sanctuaries



August 18, 2021 (Lenoir City, TN) - The Global Federation of Animal Sanctuaries (GFAS), the only globally recognized organization providing standards for identifying legitimate animal sanctuaries, awarded Accredited status to Horse Haven of Tennessee as of August 16, 2021.

Accreditation signifies that Horse Haven of TN meets GFAS's rigorous and peerreviewed equine care standards which are confirmed by a comprehensive site visit. Accreditation also signifies adherence to standards addressing the sustainability of the organization, ethical principles, finances, staffing, education outreach, security and safety and other operational aspects. The Accreditation

status also provides a clear and trusted means for the public, donors, and grantors to recognize Horse Haven of TN as an exceptional organization.

"We are very proud to announce the transition from Verified to Accredited status, for Horse Haven of TN," said Daryl Tropea, Ph.D., GFAS Program Director-Equine. "Because most of their equines come from cruelty situations, Horse Haven of TN is dedicated to providing a healing and nurturing environment, so these equines find refuge in preparation for new and lasting homes. Their focus is helping equines that need them the most, those that have suffered greatly from neglect and abuse. And in this difficult work, they strive always to follow best practices of equine care and governance because these animals deserve no less when they enter a rescue organization's care. Horse Haven of TN is clearly devoted to sustainability ensuring that they will succeed in helping many equines in years to come."

"Over the past 22 years, Horse Haven of Tennessee has worked very hard to earn the title of Tennessee's premier equine welfare organization," explained Nina Margetson, Executive Director of Horse Haven of Tennessee. "We do this by ensuring the organization's long-term sustainability along with ethical transparency and accountability. Being Tennessee's oldest and largest equine welfare organization, we feel it is our responsibility to be a shining example to others in the equine welfare community. Horse Haven of Tennessee's mission is to rescue, rehabilitate and re-home God's neglected or abused horses through programs of shelter, adoption, education, and assistance. Our programs and activities fulfill our purpose statements: 1. Rescue equine from cruel or dangerous situations; 2. Provide shelter, care, rehabilitation and adoption for abused and neglected equine; 3. Assist law enforcement with the investigation of alleged cruelty/neglect of equine and the preparation of such cases for court; 4. Provide education/training for all who handle equine cruelty and neglect calls including other equine emergencies; 5. Educate equine owners on basic requirements of responsible ownership; 6. Heighten public awareness about equine abuse/neglect including advocating for animals who cannot speak for themselves.

Horse Haven of Tennessee provides assistance to local law enforcement and state agriculture investigators for cases of abuse and *neglect* on equine (*Horses,* Donkeys, Mules and Hinnies) at no cost to the counties. Many of the counties in *Tennessee* don't have a holding facility for large animals like horses.
